#### Motion.

### **Resignation -**

Due to personal reasons Tricia Ottesen, Vice-President (Class of 2025) submitted her resignation effective immediately. There are many voids to fill as Tricia casts a large shadow and has been truly impactful to our work and spirit of our time together, such as, parish prayer life, deanery study group, nominations committee, and vice-president. To say the least, Tricia has served the Standing Committee, Bishop, and Diocese incredibly well and faithfully. Her spirit, wisdom, and skills will be greatly missed.

Information - what does the Standing Committee do in times of a resignation?

• Diocesan Canon V.4 - Standing Committee

If a vacancy occurs in its membership, the Standing Committee shall elect a replacement of the same order, who shall serve until the next Annual Meeting. At that meeting the Convention shall elect a member of the same order to fill the unexpired term.

• Anticipate a September Standing Committee Motion / Vote to elect a lay person to fill the position through the end of December 2023.

### Election -

During the November 2023 diocesan convention there will be four elections related to the Standing Committee, as managed and presented by the diocesan Nominations Committee. All elected at the Convention begin their terms January 1, 2024.

 There will be two Standing Committee Lay elections during the Diocesan Convention: one 4-year term (term ending: Matt Cameron); and one 2-year term (length to fill the unexpired term: Tricia Ottesen).

- There will be two Standing Committee Clergy elections during Diocesan Convention: one 4-year term (term ending: The Rev. Martin Juarez); and one 3-year term (length to fill the unexpired term: The Rev. Jani Wild).
  - The Standing Committee previously elected The Rev. Amber Sturgess [February 18, 2023] to fill the clergy vacancy until the 2023 Convention election. Her current term ends: 12/31/23.
